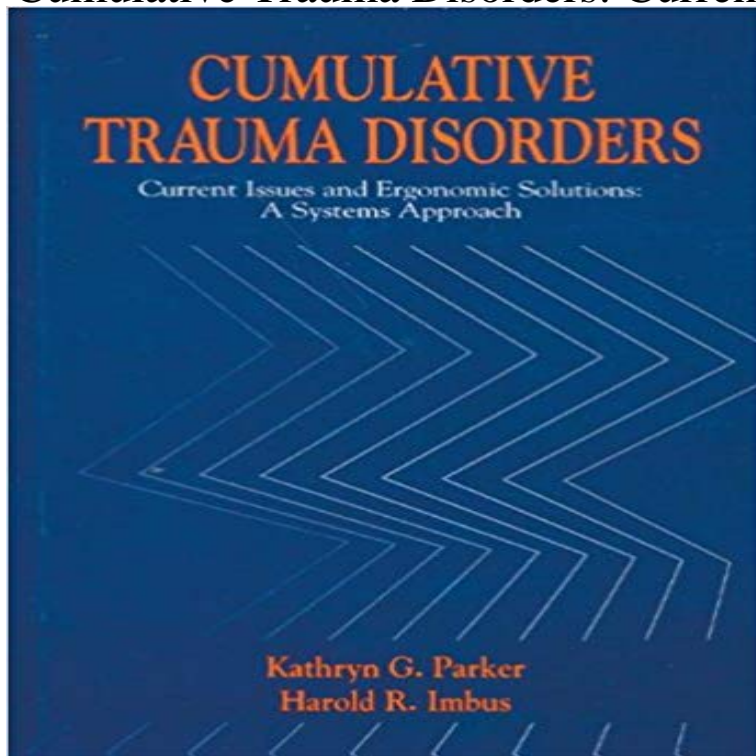


Cumulative Trauma Disorders: Current Issues and Ergonomic Solutions

Cumulative Trauma Disorders also explains many of the programmatic features included in the OSHA Ergonomic Guidelines for the Red Meat Industry, which OSHA uses as a means to structure their regulatory activities. This book discusses the rationale and value of implementing program components in the OSHA guidelines as they pertain to the production environment, presenting technical information in a clear, easy-to-read format. Cumulative Trauma Disorders is an essential book for managers of workers compensation costs, plant nurses, safety and health technicians and managers, and ergonomic consultants.
