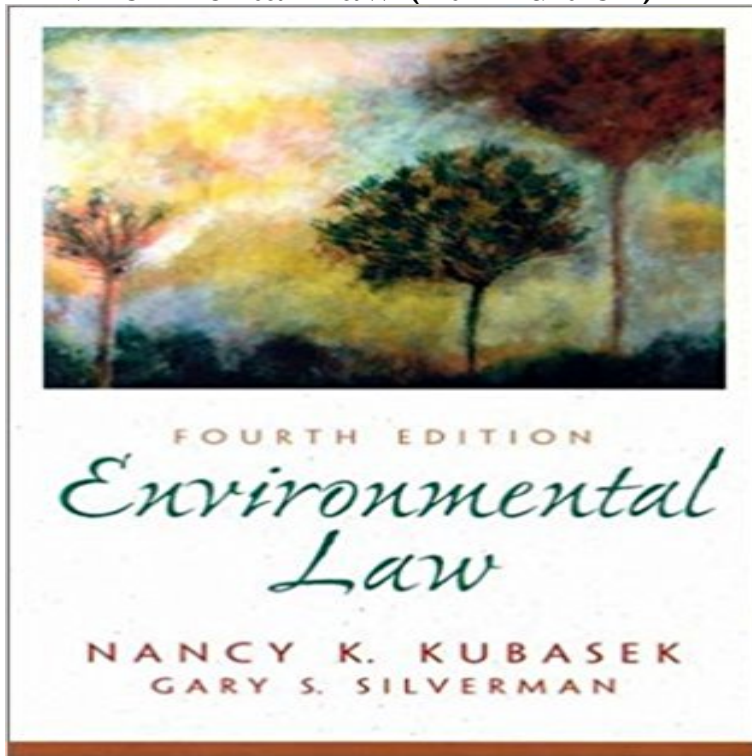


Environmental Law (4th Edition)
