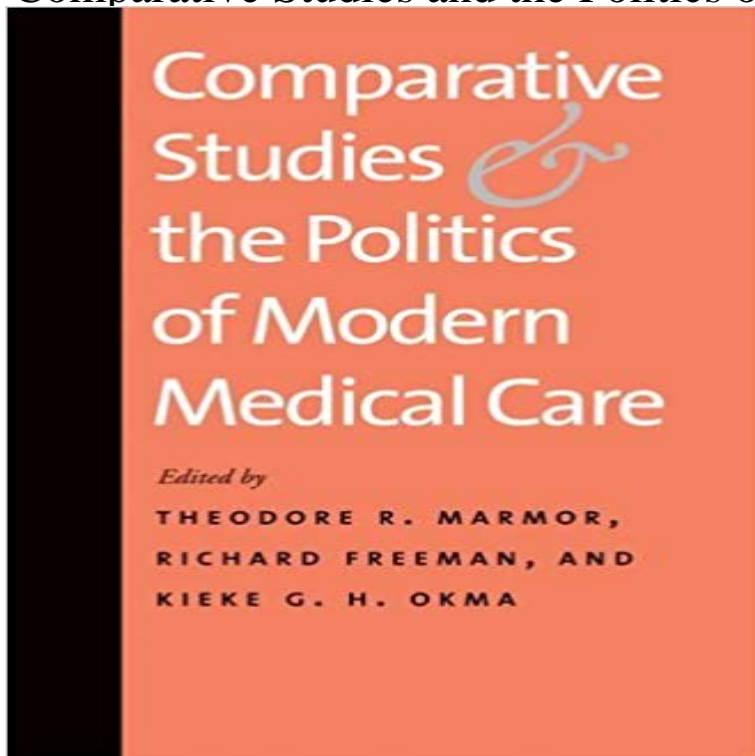


Comparative Studies and the Politics of Modern Medical Care
