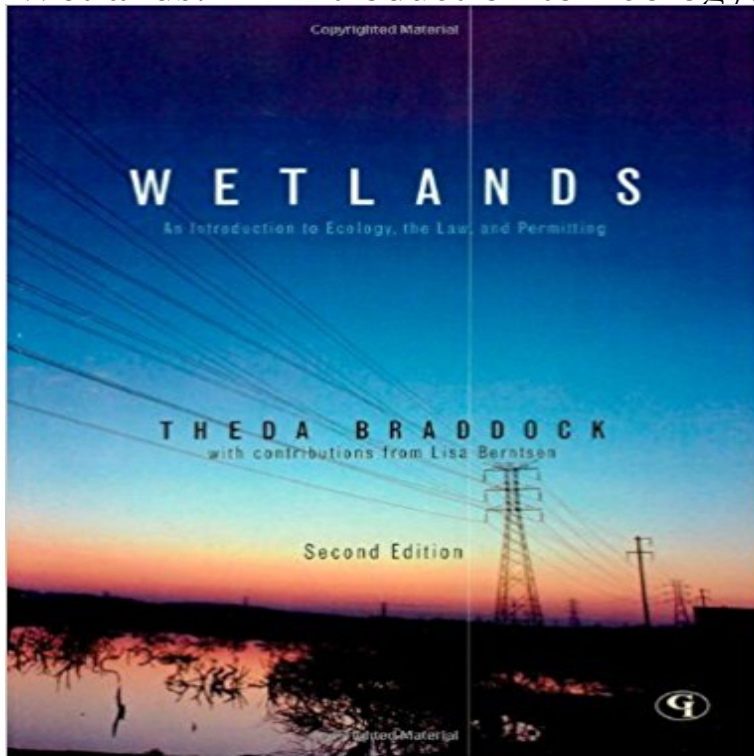


Wetlands: An Introduction to Ecology, the Law, and Permitting
