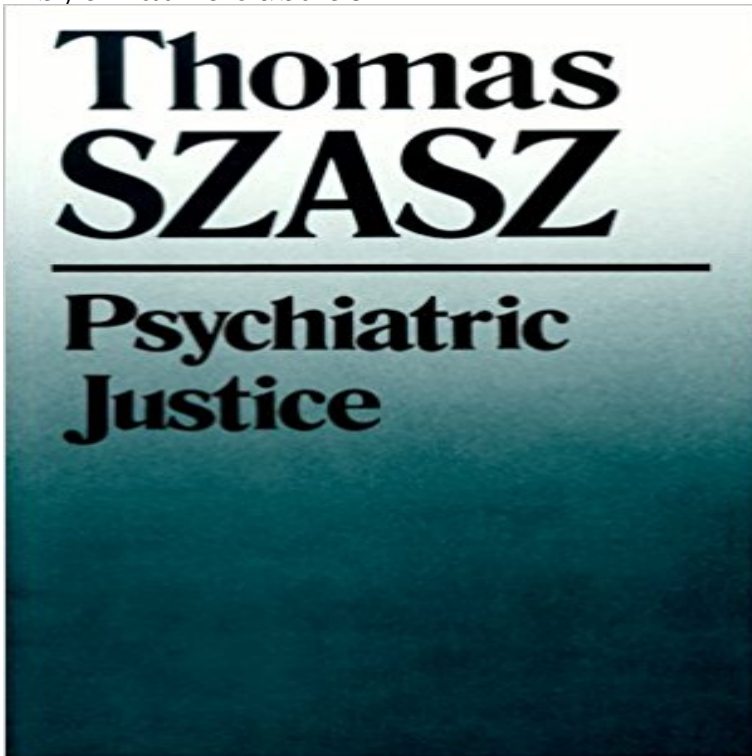


Psychiatric Justice
