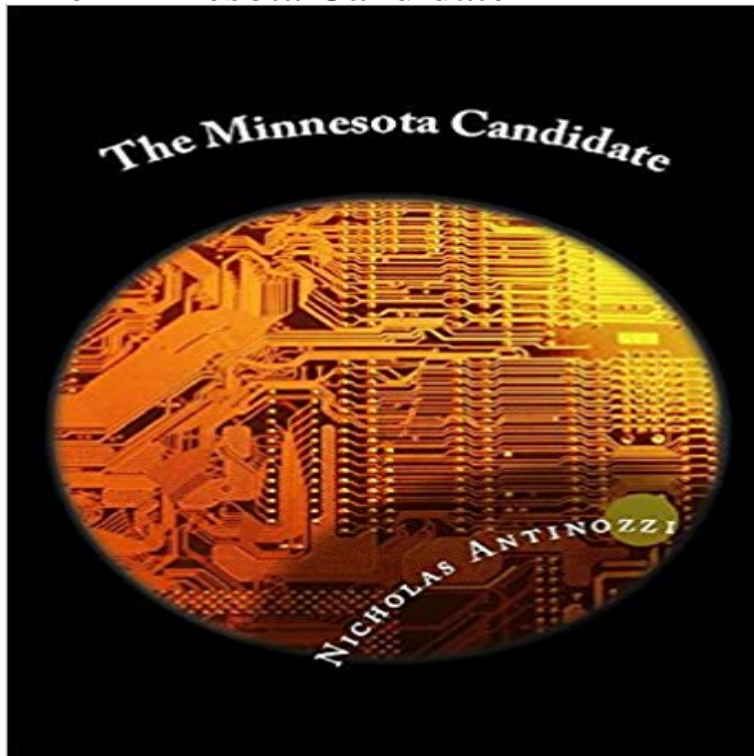


The Minnesota Candidate
